- The federal government has approved a 3% increase for our senior programs for the next 7 years.
- Raul asked for a 3% COLA
  - > Action: Approve 2021 Budget Tom Dale motioned for the Board to approve the SFY21 Budget as presented. Kelly Aberasturi seconded. All Ayes. SFY21 Budget passed. No further discussion.
