- 2. Call to Order 1:34PM
- 3. Approval of Minutes
 - Action: Approve June 1, 2022 Meeting Minutes
 - ➤ Nate Marvin motioned to approve the June 1, 2022 minutes. Reece Hrizuk seconded. No further discussion. All Ayes. June 1, 2022 minutes were approved.
- 4. Board Vice-Chair
 - Action: Accept nominations for Vice-Chair
 - > No nominations were made.
 - **Kendra Kenyon made the motion that nominations cease. Reece Hrizuk seconded. All Ayes.**
 - Action: Vote on Vice-Chair
 - ➤ Nate Marvin volunteered to fill the Vice Chair position.
 - > Kendra Kenyon made the motion to accept Nate Marvin's offer to volunteer for the position.

- 5. SFY22 Budget Closeout
 - Raul presented the Budget Closeout that ended June 30, 2022. Total Budget was \$5.3M, ARPA Funds \$1.2M, Fed \$2.9M, State Match \$1.1M. 10% carryover. Nutrition Program received \$500,000.
 - Kelly Aberasturi asked Raul to separate the ARPA Funds in the budget surplus for next year. Raul estimates that approximately \$300,000 is ARPA Funds.

- All State Funding was spent out.
- All centers but three used their modernization funds.
- Raul will cover the Discretionary Grants more often at future meetings.

6. Home Delivered Meals Projections/ 5 meals a week

- We have more people going on the program than are coming off. There are changes that need to be made to the program this next year so we become more balanced.
- We are proposing to move to 5 days a week for Home Delivered Meals instead of 7 days. Most Senior Centers are open 5 days a week. It will save approximately \$288,000.
- We would be looking at looking for a grant to help with this issue. Kendra Kenyon suggested a Community Block Grant writer for help.

7. Area Plan Final Draft

- Raul went over the comments made by the State on the Area Plan.
- Action: Approve Area Plan Final
 - Nate Marvin motioned to approve the final copy of the Area Plan. Reece Hrizuk seconded.

 No further discussion. All Ayes. The final copy of the Area Plan was approved.
- 8. Community Care Management Program
 - The main goal of the new program is to increase participation in caregivers, clients and rural communities.
 - We are looking to add a Community Health Advocate in rural communities in all six regions of Idaho.
 - Kelly Aberasturi recommended for Raul and Julie to reach out to the local County Extension Office.
 - Kendra Kenyon commented that the State did an analysis and found that if a staff member travels more than 6,000 miles a year they should have a company vehicle rather than being reimbursed for mileage.
 - Action: Approve Community Care Manager Position
 - > Reece Hrizuk motioned to approve the Community Care Manager Position. Nate Marvin seconded. No further discussion. All Ayes. Motion passed.
- 9. Phone Update This was tabled from our last meeting.
 - We are looking at moving to a Hosted Solution system.
