### 4. A3SSA SFY 2020 Budget

- Reviewed Expenses and Projections for SFY 2019
- Unspent federal funds are redistributed to the Area Agencies on Aging.
- Considerable amount of funds in I&A due to staff turnover. Staff salaries were increased to match other similar positions offered locally.
- A3SSA did not implement Case Management as planned. A3SSA did receive a grant to provide Focused Care Coordination. This is a pilot project that will provide a form of case management to adult protection referrals.
- Surplus projected for the home delivered meal program. Recommendation to increase outreach and provide technical guidance to senior centers to increase utilization of the nutrition program.
- Respite surplus is due to the difficulty of finding paid caregivers. Respite hours were increased to 20 hours to ensure funds were utilized to support caregivers.
- Reviewed SFY 2020 budget.
- An additional LTC Ombudsman position was added to ensure coverage and meet 2,000 beds per ombudsman criteria.
- Transportation, Home Delivered Meals and Congregate rates were increased.
- Funding added to support KinCare caregivers.
- Karen called for approval of the SFY 2020 budget.
